Hello Builders and Raters -

September 30 marked the halfway point in SRP's 2022-2023 program year. Thanks to all the builders and raters who are participating in this year's program. We're well on our way to meeting our goals for the year


Thanks to all of you who stopped by and enjoyed the "living room" at the SRP booth at the Southwest Builders Show in October. It was great to have a few minutes with you during the show.

There are a couple of significant changes coming up in 2023 that all builders and raters should be aware of . First, EPA ENERGY STAR Version 3.1 will go in effect for homes permitted in Arizona on or after 1/1/2023. Version 3.1 addresses several new requirements including ones that improve the HERS index of the home and some that do not. Our analysis indicates that many of the homes submitted to the program are already meeting the new threshold. The SRP ENERGY STAR Homes guidelines will be changed to reverence version 3.1 with our new program application on May 1, 2023. Builders should check with their energy raters to confirm that all their plans will be in compliance with version 3.1. Second, there are new Federal requirements going into effect for heat pumps and AC units installed in Arizona homes starting January 1, 2023. The minimum allowable rating will be **SEER** 15. There is a "seil-through" allowance for heat pumps, but not AC units. Be sure to check with your HVAC contractor and your energy rater about these upcoming changes.

(§) Rebate Funds Available



Currently, the SRP ENERGY STAR Homes Program has 50% of the rebate funding available. Builders earn performance incentives by improving energy efficiency on each home at \$.12 per kWh. Incentives are determined by the home's total estimated annual kWh savings as compared to a code-built home. The builder's rater shall determine the kWh savings using Ekotrope software. SRP will pay incentives for eligible homes on a first-come, first-served basis until all incentive funding has been depleted for the fiscal year

Don't forget builders may earn an additional incentive of \$300 per home for Electric Vehicle-Ready homes
