May 1, 2025 to April 30, 2026	E-31, E-32, E-33, E-34, E-36, E-47, E-48, E-61, E-63, E-65, E-66, E-67	Up to \$300,000 for EV Charging rebates and up to \$100,000 for Electric Technology rebates.

Customers are subject to a maximum rebate of \$450,000 from May 1 through April 30 for all SRP programs, with separate program area caps of \$300,000 for Energy Efficiency programs, \$300,000 for Business EV programs, and \$100,000 for Electric Technology programs. Program or technology-based limits may also be applicable, based on program terms and conditions. SRP reserves the right to determine at their sole discretion the program year to which a rebate is attributed.
